



2021 IMDA AWARDS COMPETITION

The 2021 IMDA Awards Competition will recognize outstanding IML, IMD and IME submissions that were produced in 2020 or are slated for release in 2021. Entries received from around the world will showcase the best in in-mold design and technical achievement, and this year's competition features new categories to recognize the innovations related to sustainability and the COVID-19 pandemic.

JUDGING

Judging will be performed by individuals who are knowledgeable in in-mold processes. Judges will look at overall design and complexity; integration of the in-mold element into the part or package; functionality; and innovation in the use of materials and processes. Manufacturing difficulty and complexity of the part, label, design or mold also are considered.

To ensure fairness, submitting companies are masked during the judging process, and no judge may cast a vote for any entry submitted by his/her own company. Judges will select a winner in each category, and a "Best of Show" will be chosen from among all category winners. The decision of the judges will be final, and no correspondence will be provided regarding details of the judging.

INDUSTRY RECOGNITION

Award winners in each category receive the following:

- A personalized award certificate suitable for display
- Recognition with a photo of the submitted entry and production details on the IMDA website
- Recognition in the October/November issue of *Plastics Decorating* magazine
- Additional recognition and display in other industry publications and at industry events, including *Label & Narrow Web* magazine, during the IMDA Symposium and at the Brand Zone at PACK EXPO Las Vegas

- There is no limit to the number of entries a company can submit.
- IMDA retains the right to re-categorize as necessary. This assures the fairest judging and affords the entrant the best opportunity for an award in the competition.
- Entries cannot be returned and become the property of IMDA.
- Any company engaged in the production or design of in-mold products may enter. It is not necessary to be an IMDA member. However, entry fees to non-members are higher.
- IMDA reserves the right to share images of entries.
